Purpose of the Community Development Framework



The purpose of this framework is to guide, support and inform the Tasmania Fire Service Community Development Team when engaging with at-risk communities in community safety. The framework facilitates the alignment of service delivery with contemporary fire and emergency services strategic directions, state, national and international strategies.

This framework sits under the Fire and Emergency Services Strategic Plan - Framing our Future. The day to day business of the Community Development and Education Unit is guided by the Division of Community Fire Safety Business Plan and the Unit Business Plan.

Vision

A Tasmanian community that is safer and more resilient to the impact of fire and other emergencies.

Mission

To be an emergency management leader and partner in the community safety space in prevention, preparedness and response.

This includes being adaptable and compatible with broader emergency management strategies for fire and other emergencies.



Through a contemporary community development approach:

- 1** Raise community preparedness levels in relation to fire and other hazards in identified communities and with risk groups.
- 2** Consult, collaborate and engage internal/external stakeholders and communities to develop and implement local resilience strategies.
- 3** Bench marking (best practice), innovation and continuous improvement, including documenting and evaluating community outcomes in behavioural change.
- 4** Align with strategic organisational direction in emergency management.

Community Development Definition (Community Fire Safety Context)

The process of working with at risk communities to identify and implement strategies to strengthen and develop resilience to fire and other emergencies. This process is guided by the Tasmania Fire Service Customer Service Charter.
